#### President's Remarks and Focus:

Had a nice HPDE at La Junta on 18-19 Oct. Noted we had 92 members for dinner at Pueblo for the PCA 70<sup>th</sup> celebration on 13 Sept. Need nominations for annual awards from Board members. Also consider nominations for National awards. Noted that as of Dec 2026, five board members will have completed the allowed two terms and are not available for re-election to their positions: Steve, Pam, Robin, Geof, Jackie. Need to encourage members to volunteer for election to these positions.

Steve needs to submit our charity contributions to National for subsidy grant. Greg to pull data together.
