President's Remarks and Focus:

Bishop's Castle tour went well this past weekend. However, there were not enough Leads/Sweeps for the 21 cars participating. We need more members to step up and volunteer to support our AMR activities such as this. Need to start grooming candidates for Board positions coming up for election the fall of 2026.

Previous Meeting Minutes: Minutes of April 29th meeting were approved by voice vote.

Committee Reports:

Treasury: Pam presented the treasurer's report. May income was \$13,621 and expenses were \$6,880. Primarily, expenses were for future socials and HPDE's. Approved by voice vote.

Registrar: Bishop's Castle tour was a success. Santa Fe/Taos tour is registration is closed. Big Mission social on 29 May is closed with 100 registered. Discussed need to check in registered participants.

HPDE Program: La Junta HPDE was a success: Participants had a good time and weather was perfect. There were no safety issues. Robin noted that we made \$1400 on the this HDPE.

Pueblo HPDE will be 12-13 July. Will be training two new Chairs at that event.

Brenda requested guidance on sending written invitations to all 29 past presidents. Decision was to send only to those currently registered in AMR. Steve will provide memorabilia for a silent auction. There will not be a typical “social raffle”. 250 etched glasses have been ordered for participants. Discussed potential for a Concours as part of the event. It was decided that instead we would offer a “People’s Choice” vote on their favorite car. Suggested we contact Lou Morales for potential categories. Requested Brenda draft an announcement for MReg and send to Steve. Cost will be \$75 per person.

August social will be on Saturday, 30 August at Iron Springs Chateau in Manitou Springs. Cost will be \$47 per person. Board affirmed that the budget was approved at the last board meeting.

Tours: Santa Fe/Taos tour has 14 cars registered and 20 people. Approximately half of the participants will be coming from the western half of Colorado. Need someone to conduct the safety briefing at Porsche COS that Friday morning. In general, we also need more volunteers to help with tours.

Charities: No report. Robin noted that Hot Wheels have been collected at the HPDE.

Website: Second half of the development cost has been paid. Board review of draft website has been very good. Some minor things to add/touch up and then go live.
